
### About Us

#### **Deputy Sheriffs**

Charles County Deputy Sheriffs work day and night to protect the citizens of Charles County. They adhere to high standards and demonstrate honor, integrity and dedication to duty.

Patrol deputies are the most visible component of the Sheriff's Office and serve as first responders to emergency and non-emergency incidents in the County. Patrol deputies are assigned to district stations located in Waldorf, La Plata and Indian Head.

Deputies also work in the Agency's other divisions, including Criminal Investigations and Special Operations. Their opportunities for speciality assignments include the Major Crimes, Special Victims, Narcotics/Vice Enforcement, Financial Crimes, K9, Community Policing, Traffic Operations, Alcohol Enforcement, Warrant/Fugitive and Juvenile Resource units and the Tactical Response Squad.

In addition to their Agency assignments, deputies may also volunteer for the Emergency Services Team, Hostage Negotiations Team and Honor Guard.



# **Requirements**

• Deputy Sheriffs must be 21 years of age upon graduation from the Southern Maryland Criminal Justice Academy

• Applicants must possess a high school diploma, or equivalent, accepted by the Maryland Department of Education

- Applicants must have United States Citizenship
- Applicants must have a valid driver's license

• Applicants must: (1) pass a written test, (2) pass a physical agility test, (3) appear before an interview panel, (4) pass an intensive background investigation, (5) pass a polygraph examination, 6) pass a

physical examination and 7) pass a psychological examination.

• Recruits must complete a sixmonth training program at the Southern Maryland Criminal Justice Academy

• Upon appointment, deputy sheriffs will be subject to a two-year probationary period

# **Salary and Benefits**

The Sheriff's Office offers a competitive salary for deputy sheriff.
