## **Congratulations Graduates!**

Yes it's that time again. Young adults will be graduating from high school and heading out to college or a job. From kindergarten to first grade, fifth grade to middle school and eighth grade to high school. This is a time of change for lots of families in Charles County. Getting a diploma is not getting a license to drink.

If your high school graduate is celebrating after the ceremony, talk to them about underage drinking and drinking and driving. Don't hesitate to discuss your expectations and how to avoid dangerous situations. National surveys show that a majority of high school teens get alcohol at their home, with or without their parent's permission. House parties are the primary place that teens drink. If a teen finds themselves in an uncomfortable situation, let them know they can call you no matter the time.

Make sure your child knows not to get in a car with someone who has been drinking or doing drugs even if they seem ok.

Know where the parties are and make sure there

will be adults present. If hosting a party don't allow water bottles and backpacks into the party. Ensure that the teens know areas they are not allowed to be in your home. Lock all liquor and medicine cabinets. Have a responsible adult at the door to enforce the guest list. Call another child's parents if he or she brings alcohol to your home.

Saying no doesn't mean you love your child any less. Be the **Parent!** Your children already have enough friends.

## Never Leave a Child Alone In a Car.

As summer temperatures continue to go up, it's important to remember that while these summer days are great at the pool and the beach, they're not so good for the inside of cars, which can raise to deadly temperatures in a very short period of time. Children have been left in vehicles when the temperatures were as hot outside as 100 degrees and as mild as 76 degrees and have died. Losing even one child after being left in a vehicle is unacceptable. Many people are shocked to learn how hot the inside of a car can actually get. On an 80 degree day, the temperature inside of a car can rise 19 degrees in 10 minutes and keep getting hotter with each passing minute. You can only imagine what happens when the temperature outside is 100 degrees or

more. Cracking the window doesn't help. Heatstroke sets in when the body isn't able to cool itself quickly enough. Young children are particularly at risk, as their bodies heat up 3 to 5 times faster than an adult's. When a child's internal temperature reaches 104 degrees, major organs begin to shut down. When that child's temperature reaches 107 degrees, the child can die.

At least two children die per week in hot vehicles on average during the summer months, the National Safety Council says. The majority of children who die of heatrelated complications from being inside a hot car were left there by parents who forgot about them. But a startling number-17%died because they were left in those vehicles intentionally.

Thirty-nine children died of heatstroke after being left in vehicles in 2016, up from 24 the previous year, NHTSA reported.

Protect children by remembering ACT:

**A.** Avoid heatstroke related injury and death by never leaving your child alone in a car, not even for a minute.

**C.** Create reminders by putting something in the back of your car next to your child such as a briefcase, a purse or a cell phone that is needed at your final destination.

**T.** Take action. If you see a child, older adult or pet left alone in a car, call 911. Emergency personnel are trained to respond to these situations.
