**(Custom Blouse) (Brown)**



#### **Specifications:**

- 25/75 Wool/Polyester blend
  - All buttons to be Sheriff Gold gilt "S" buttons surrounded by a wreath. Three (3) 36 Ligne Gilt "S" buttons, one (1) 34 Ligne black bone button sewn on front approx. 3 ½" apart and one (1) 24 Ligne Gilt "S" button on each pocket flap and shoulder strap. Two (2) 24 Ligne Gilt "S" button sleeve buttons, bottom button 1" up sleeve cuff and spaced 1" apart.
  - Taupe epaulets pointed to button (Double cloth) cross stitched and 2" from shoulder seam.
- Sleeve to have one (1) row, 5/8" gold braid for Lieutenants and above – Taupe braid for Sergeants and below, 3" up from cuff and all around sleeve.
  - Two (2) breast box pleated pockets, three (3) pointed flaps to button – 6 ¼" deep – 5 ½" wide.
  - One (1) pocket on inside on right side
  - A 1 ½" expansion to be sewn in bi-swing
  - Black metal badge tab on left breast 1" above left breast pocket
  - Coat fully lined with black acetate twill lining
  - Linen label with care instructions sewn inside breast pocket
  - Silk label sewn inside below opening of inside breast pocket

Sew 3 each - ½" Gold Sleeve Braid (Rice 96) for Major on both sleeves.

**ITEM #01-D – DRESS BLOUSE GOLD SLEEVE BRAID**



Sew 4 each - ½" Gold Sleeve Braid (Rice 96) for Lieutenant Colonel on both sleeves.

Sew 5 each - ½" Gold Sleeve Braid (Rice 96) for Sheriff on both sleeves.

Sew two (2) black belt hooks on back on each side below bi-swing back for sworn officers Sergeant and below.

**ITEM #01-03 – Men's T-3 Elastique 100% Visa® System 3 Polyester Trouser  
(Fechheimer - 32223) (Pink Tan)**



**Specifications**

- 100% Polyester
- 12.5-13-oz. Elastique weave
- They're defined by "T" styles that determine the pocket and belt loop options. Many features are built into each trouser
- The left back pocket will have a button tab. Front pockets will have bartacks with ¼" top pockets. Back pockets shall have bartacks
- Waistband will have a ¾" stiffener sewn into the waistband on the front of the trouser from side seam to side seam. The waistband closure will be crushproof hook and eye, bartacked for stability.

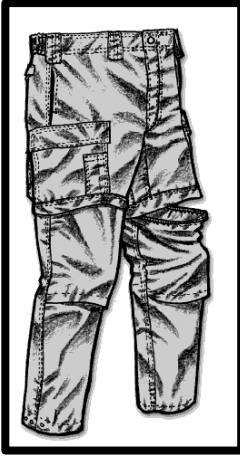
